# **Policy on Academic Remediation**

## I. POLICY

A student who has failed to make satisfactory progress towards the MD degree will be considered by the Committee on Student Promotions.

If the Committee on Student Promotions determines that remediation is indicated, the Committee will determine the acceptable remediation approach. The following table summarizes the usual approaches that may be selected for specific situations:

During year 1 coursework, a second failure in a curriculum section that is being repeated would lead to automatic dismissal. The University of Pittsburgh policy is that a student may only register twice for any section.

All curriculum sections of year 1 must be successfully passed before entry into year 2.

<sup>\*</sup>NOTE: A student who is required to repeat the entire year will be required to take and pass all of the courses during that year, including courses that had previously been completed satisfactorily. This applies to all curriculum years.

Students who fail courses must be provided with an opportunity to remediate their failing performance and to develop the necessary level of mastery of the subject matter. The Committee on Student Promotions has a key role in determining the type of remediation activity that is appropriate for each student's situation. The faculty on the Committee on Student Promotions are charged to globally evaluate individual student performance and use their judgment in making decisions. This policy defines the usual approaches that may be selected for specific situations.
